Explanatory Statement pursuant to the provisions of Section 102 of the Companies Act, 2013, annexure to and forming part of the Notice

The following Explanatory Statement relating to the accompanying Notice sets out all material facts:

The Board of Directors of the Company at its meeting held on September 26, 2019 had subject to the approval of the Reserve Bank of India, appointed Ms. Shilpa Gattani as Director of the Company. RBI vide its letter dated December 31, 2019 accorded its approval for the appointment of Ms. Shilpa Gattani as Director on the Board of the Company.

Further, Mr. Sanjay Shah, an Independent Director, on the Board of the Company resigned with effect from January 14, 2020. Accordingly, the Board of the Company comprises of 2 Directors namely Mr. Mitul Shah and Mr. K Siddharth, below the statutory minimum of 3 Directors prescribed under the Companies Act, 2013 and the Rules framed thereunder (the Act).

Further, as per the provisions of the Act and the Articles of Association, where the number of Directors have fallen below the minimum number of Directors, the continuing Directors may act for the purpose of increasing the number of Directors to the statutory minimum. Therefore, it is proposed to convene an Extraordinary General Meeting of the members to increase the number of Directors to 3 by appointing Ms. Shilpa Gattani as Director of the Company.

The Board recommends the Resolution set forth in the Notice for the approval of the members as an Ordinary Resolution.

None of the Directors, Key management personnel of the Company and their relatives, are in any way, concerned or interested, financially or otherwise, in the Resolution as set out in the Notice.
