

I ON A CLEAN TRIPH With eye on revenue, Panvel bats for clean-up marshals

They will also assist civic body in taking action against single-use of plastic; collecting fines for not wearing masks, spitting and open defecation

On the lines of the BMC, the Panvel Municipal Corporation (PMC) has appointed an agency to provide clean-up marshals across the city. These marshals will ensure cleanliness of the city and collect fines from people littering. They will also assist the civic body in taking action against single-use of plastic.

A proposal to appoint an agency was cleared during the standing committee meeting held on Wednesday on a revenue-sharing basis. While the civic body will keep 69 per cent of the fines collected from citizens for violating rules, the agency appointed will get the remaining 31 per cent.

While the clean-up marshal model has been severely criticised in Mumbai for harassing common citizens in the name of cleanliness, the fiveyear-old civic body is exploring options to generate revenue. The issue of property tax collection has not yet been resolved as many citizens are not ready to pay retrospective taxes.

While clearing the proposal, the civic chief said it will help make the city cleaner and create a sense of respon-

sibility among residents. As per the proposal cleared by the standing committee, a fine of Rs 150 will be collected for littering on public roads, and Rs 100 for open urination. Similarly, cleanup marshals will collect Rs 500 for open defecation, and Rs 100 for spitting. If any commercial estab-

lishment is found with the banned single-use plastic, clean-up marshals, along with civic officials, will collect Rs 5,000 for the first offence, Rs 10,000 for the second one, and Rs 25,000 for the third offence. As segregation of waste is

important to ensure less waste reaches dumping grounds, Rs 50 will be collected if waste is not segregated for the first time and Rs 100 for the second time. If the

same person does not segre gate the waste, s/he will have to pay a fine of Rs 150.

Like Mumbai, marshals will collect Rs 200 from people for not wearing masks and Rs 1,000 for spitting in the public and in crowded areas.

However, the majority of the residents echoed that the civic body should first provide a sufficient number of public toilets to prevent people from urinating in open
